Contractual Necessity

How long will we keep your data for?

The Right of Access

This Grants you the right to confirm whether or not your personal data is being processed, and to be provided with all the relevant details of what those processing operations are.

The Right of Erasure ('Right to be forgotten')

You have the right to request that we erase all personal data we have about you, and we must respond to that request without undue delay. There are some conditions that apply with this right, but we will make every attempt to respond to a 'Right to be forgotten' request within 30 days of receiving it.

The Right to Rectification

If you should notice that the data, we have about you is inaccurate or incomplete, you may request we rectify the mistake. We will make every effort to respond to requests of this type immediately.

The Right to Restriction

You have the right to have us restrict the processing of your personal data and ensure that processing only takes place with your consent or for legal purposes.

The Right to Objection

If for any reason you wish to object to the way we use, or have used, your personal data you may do so by contacting us using the contact details listed below.

The Right to Portability

Should you request us to do so then we must pass on all of the details you have given to us to another provider of your choosing.

The Right to Complain
